



Northshore Fencing Club Waiver of Liability & Release of Indemnity 2026

Acceptance of Rules

Upon entering activities, classes, and events sponsored by the Northshore Fencing Club / Grace Buchanan, I agree to abide by the rules of Northshore Fencing Club, as well as those currently published by USA Fencing.

Statement of Risk and Release of Liability

Fencers and parents of fencers involved with the Northshore Fencing Club should know the risks inherent in the program's activities, classes, and events. These risks include accidents, illnesses, or injuries- including death during participation. Although Grace Buchanan and Northshore Fencing Club go to great measures to eliminate these risks, they cannot be eliminated completely. Grace Buchanan, Northshore Fencing Club, Northshore Vultures, Lakeshore Church & Coquille Sports & Recreation, its employees and agents assume no liability for Northshore Fencing Club activities, classes, and events. The participants are solely responsible for their health, safety and welfare.

RELEASE AND INDEMNITY As a participant of Northshore Fencing Club's activities, classes & events, I affirm that:

1. I am aware of my physical condition.
2. I am voluntarily participating in fencing events.
3. I am assuming all risks arising from my participation in the activities, classes, and events.

Releasees: Grace Buchanan, Northshore Fencing Club, Northshore Vultures, Lakeshore Church, The Collab Covington & Coquille Sports & Recreation or their agents and employees

Release: In consideration for facilitating my participation in Northshore Fencing Club activities, classes, & events, I release, discharge, and agree not to sue Releasees for any claims demands, actions, and causes of action of any nature whatsoever including a claim of negligence, arising out of any loss or damage to my property and any injury, including death, that I may sustain whether or not caused by the negligence of the Releasees, while participating in the Northshore Fencing Club activities, classes, & events, supervised or unsupervised.

Risks: To the best of my knowledge, I am in good health and have no physical limitations that would preclude or impede my participation in fencing activities, classes, and events. I am aware of the risks and hazards connected with these activities, classes, and events, and I elect to participate voluntarily and engage in the event knowing that the program may be hazardous to my property and me. I voluntarily and expressly agree and promise that I assume full responsibility for property loss or damage, and for personal injury, including death, that I may sustain as a result of being engaged in the program, whether or not based on the negligence or other wrongful conduct of Releasees.

Indemnity: I also agree to indemnify and hold harmless the Releasees from any and all loss, liability, damage, or costs of any nature whatsoever, including court costs and attorney's fees, that they may incur due to my participation in the Northshore Fencing Club activities, classes, or events whether caused by the negligence of Releasees or otherwise. For example, I specifically agree to indemnify and hold harmless the Releasees from losses they may incur as a result of my injuring another person or damaging another person's property while participating in the activities, classes, and events.

Intent: I intend that this Statement of Risk and Responsibility and Release of Liability bind not only me, but also the members of my family and my spouse (if any), if I am alive, and my heirs, assigns and personal representatives, if I am not alive. I intend this as a release, discharge and promise not to sue Releasees. I further agree that this Statement of Risk and Responsibility and Release of Liability should be construed in accordance with the laws of the State of Louisiana.

This Statement of Risk and Responsibility and Release of Liability supersedes any verbal commitments to the contrary concerning the responsibility of Grace Buchanan, Northshore Fencing Club, Northshore Vultures, The Collab Covington, and Coquille Parks and Recreation or their agents and employees. I verify that I have read, understand, and agree to this Statement of Risk Release of Liability. I understand it and sign it voluntarily as my own free act. I certify that I am of lawful age (18 years or older) and legally competent to sign this agreement OR my parents are present and will sign this agreement on my behalf.
